Mission Statements

Council discussed Mission Statements, including Standard I requirements for, Cuyamaca College, Grossmont College, and the District.

DISTRICT:

Chriboga disseminated a handout with recommended changes to the District Mission Statement. Council reviewed and by consensus, recommend the following changes:

First paragraph:
First Sentence.

Change from, “The Grossmont-Cuyamaca Community College District’s mission is to provide leadership through learning opportunities”:

Change to: “The Grossmont-Cuyamaca Community College District’s mission is to provide leadership for learning opportunities”:

Add bullet reference to: “The Community College District fulfills the mission by providing:

- *Institutional Research and Planning* (under first bullet point)

Replace “By these means” reference, to “In these ways, the District insures responsible.....”

Paragraph three: Recommended suggestion is:

Through its activities, the District seeks to facilitate and support the colleges as each seeks to provide quality instructional programs; community education and services; and programs that promote and support economic development.

Strategic Direction

Recommended changes:

The Way Forward, the adopted District-wide leadership philosophy and strategic approach, identifies values and direction to accomplishing the District's mission.

GROSSMONT COLLEGE

Council reviewed and by consensus, recommend the following changes:

Intro statement: No changes.

Educational Objectives:

Change the sentence "The primary mission of Grossmont College is to provide;"

Change to: *"In support of its primary mission to promote student learning, Grossmont College is to provide:*

The first bullet point reads, "Instructional programs that meet students' needs for....." should read, *"Instructional programs that meet student needs for..."* the s' to be deleted.

Bolded statement, which reads, "To support this mission, Grossmont College...."

Recommended change:

To facilitate this mission, Grossmont College provides a comprehensive range of support services for students including: outreach and access initiatives, academic and learning resources, student development programs, multi-cultural and co-curricular activities.

CUYAMACA COLLEGE

Bolded statement, which reads, “To support this mission, Cuyamaca College....”
