### 2nd Read BP/AP 5035 Withholding of Student Records for Nonpayment of Financial Obligations Due to AB 1313, we can no longer withhold transcripts; therefore will be reviewed by VPSS and Dean/Director of Admissions and Records. BP/AP 5050 Student Success and Support Program – No updates - This is a CCLC update. Raad Jerjis and James Canady will review this with their counseling teams. It was suggested that we would need some technical assistance to comply and monitor our BP/AP, such as the tracking of a student educational plan no later than the term after which the student completes 15 semester units of degree applicable credit coursework. The CCLC version stops at the red, GCCCD added exemption and violation appeal portion. 3rd Read **BP/AP** 4105 Distance Education This is a CCLC update. Jeff and Cindy took this to their Distance Education Coordinators and made recommendations. - It was suggested that this be taken back to the coordinators to review for repetition and state authorizations. **BP/AP 5015 Residence Determination** - This is a CCLC update and the council recommended Admissions and Records to review. **BP/AP 5020 Nonresident Tuition** - This is a CCLC update 35 and the council recommended Admissions and Records to review. - Aaron stated that he would like to review this policy again. 4th Read **BP/AP 5520 Student Discipline Procedures** Proposed to go to DEC in May however it was recommended to highlight only the main points/content
