BP/AP 4250 Probation, Dismissal, and Readmission

- Update: A recommendation came from Cuyamaca's Student Success and Equity Council to pause the probation and dismissal process.
 - Barbara gave Grossmont a chance to review the request at their Student Success and Equity Council.
 - Barbara indicated the process is mandated to run by Title 5 and there is no relief from the state to not run the process. The loss of BOG process utilizes the probation and dismissal process to determine which student will lose their BOG.
