**Recommended Action** Approve the East County Education Alliance Partnership Agreement between Grossmont-Cuyamaca Community College District, Grossmont Union High School District, and Mountain Empire Unified School District.

**Summary of Issue** Grossmont-Cuyamaca Community College District (GCCCD), Grossmont Union High School District (GUHSD), and Mountain Empire Unified School District (MEUSD) hereby enter into the East County Education Alliance (ECEA) partnership agreement, approved by their respective governing boards. The agreement is presented as **Attachment A**.

This agreement will be reviewed for approval on an annual basis.

**Background** In 2014, GCCCD and GUHSD developed the ECEA to increase collaboration between the two districts so that students are better informed about their college and career options after high school and have a smoother path to college. ECEA welcomed MEUSD to the partnership in 2019.

**Support of Strategic Planning** This agreement will allow the parties to continue the collaborative efforts of our East County community with the goal of developing seamless pathways from high school to community college.
